10. Presentation of Committee Reports

<u>Personnel</u>: Diane Sasso said the committee met with Susan Grierson to review the goals that were established for her over this past year and that the committee would meet again in June to discuss and put in place her goals for the coming school year.

<u>Fundraising</u>: Brian Blake spoke of the desire to ask Friends of Elysian to increase their annual contribution to the school. Members of the committee spoke with Friends Chair, Jen Semenza, who requested that Friends be provided with specifics of what the additional money would be used for. Fundraising Committee members agreed it would be a good idea to attend an upcoming Friends meeting as well as assist in recruiting more of our school community to join Friends.

<u>Academic</u>: Maria Badali said that the committee met to discuss their goals and how pleased she was with the staff representation on the Academic Committee and how they hoped to get more tenured teachers to join. There was a discussion at the first meeting on the importance of technology in the classrooms. Jen O'Callaghan suggested that we formally thank the Stevens University students who worked so hard on our new 5 year strategic plan.

<u>Outreach</u>: Andrea O'Connor said the committee had their first meeting and identified the communities that should be targeted:

- 1) The Elysian Community how can we get more people/families involved
- 2) Hoboken Community devise ways to actively recruit families to enter the 3:1 lottery
- 3) Statewide Charter School advocacy work more closely with the other charter schools
