V. Faculty Representative Report:

Samantha shared Hillary's concern over the number of student absences over the recent February break due to the fact that it spanned over 2 weeks. A discussion followed about possible ways we can prevent this and that it needed to be addressed when planning the 2020-21 calendar.

Upon recommendation of the Director of Elysian Charter School the following resolutions are presented for approval:

Finance:

- 1. Resolved that the Board of Trustees approves the Payroll Report of January 15, 2020 in the amount of \$140,809.05.
- 2. Resolved that the Board of Trustees approves the Payroll Report of January 30, 2020 in the amount of \$140,327.00.
- 3. Resolved that the Board of Trustees approves the January 2020 Check Register in the amount of \$326,075.60.
- 4. Resolved that the Board of Trustees approves the Board Secretary and Treasurer Reports for January 2020 as per attached.

Pursuant to N.J.A.C. 6:23-2.11(a)4, the Board of Trustees acknowledges receipt of the secretary's certification, and after review of the monthly financial report (appropriations section) certifies that, to the best of its knowledge, as of January 2020, no major account or fund has been over expended in violation of N.J.A.C. 6A:23-2,11(b), and that sufficient funds are available to meet the school's financial obligations for the remainder of the fiscal year.

5. The State of New Jersey Department of Education permutes requests for waiver of the SEMI. The State of New Jersey Department of Education permutes requests for waiver of the SEMI program in school districts with 40 or fewer Special Education/Medicaid eligible students in the 2020/21 fiscal year. Upon recommendation by the Director, we will apply for a waiver given that Elysian Charter has a Projected Medicaid-Eligible/Special Education student count of 9 and the application would not be cost-effective for the school; Resolved that the Board of Trustees of the Elysian Charter School hereby authorizes submission of the SEMI FY21 waiver request attached.

In light of the recent expansion denial, Diane Macon shared that she has been working on various cost saving measures which she will email to all Board members for further discussion at the March meeting.

Personnel:

- 6. Resolved that the Board of Trustees of Elysian Charter School in accordance with N.J.A.C. 17:27-3.2 appoints Diane M. Macon, Business Manager, Board Secretary as the Public Agency Compliance Officer for the Elysian Charter School of Hoboken.
- 7. Resolved that the Board of Trustees of Elysian Charter School appoints Daisy Tavarez as a one to one part time aide at a rate of \$15.00 per hour for the remainder of the 2019-20 school year. Total salary not to exceed \$2,610.00.

8. Resolved by the Board of Trustees of Elysian Charter School to approve adding Vanetta Rivera and Jowa Alfano to the substitute teacher list for the 2019-20 school year. The rate of pay will be \$95.00 per day. This is an as needed position therefore not eligible for benefits such as health, dental insurance and pension.
