1. Funds will be used to mitigate any issues regarding air quality and to ensure safety of our students, staff, and community when entering or leaving our building. By providing the proper PPE supplies as well as continuous cleaning of all areas of the building, we can ensure that our school remains a safe in person learning environment for low income, migrant, students with disabilities, and economically disadvantaged students as well as our whole student body and staff.

The LEA will use the reserved funds plus additional funds for after school programs such as Visual and Performing Arts, Music, STEM, Academic and Socialization clubs for both after school during the academic year, as well as for the summer, enabling our students who are in need the most, to have the opportunity to join these programs along with the balance of our student body.

Balance of funds will be used for professional development of the staff and to investigate additional technological innovations that can be useful to our most affected students. In addition, hot spot purchases will also increase for these students to have the opportunities to join from home or continue the program when unable to attend in person.
